
ORDER GRANTING PRELIMINARY INJUNCTION

Now come the parties, by counsel, on Petitioner's Motion for Injunctive Relief enjoining enforcement from its effective date of July 1, 2009, of Article 954 of the Codified Ordinances of the City of Huntington. The parties announced to the Court they had agreed to entry of an Order granting the Motion for Injunctive Relief and enjoining enforcement of said Ordinance, with a hearing to be set prior to December 31, 2009, on the question of whether an injunction permanently enjoining enforcement of said Ordinance should be granted.

It is accordingly **ORDERED** that enforcement of Article 954 of the Codified Ordinances of the City of Huntington be enjoined effective July 1, 2009, with this preliminary injunction to continue until such time as the Court rules on the Petition to permanently enjoin Article 954.


Further, a Status Conference shall be scheduled by the Court within thirty (30) days of entry of this Order.


